2016 NM Legislative Session – Prescribed Fire Memorial (Draft Language)

Where as...Fire is an environmental driver and an essential part of most New Mexico ecosystems...

Where as...Fire is an important tool used by NM agriculture to clear fields, clean ditches, and burn debris...

Where as...Prescribed fire is an important tool used by NM livestock industry to maintain open grasslands and improve forage quality...

Where as...Cyclic burning in NM forests and woodlands promotes forest health and reduce the risk of catastrophic wildfire...

Where as...Fire maintains and improves NM wildlife habitat...

Where as...Natural fire regimes promote desirable hydrologic function...

Therefore...The NM legislature promotes the continued use of prescribed fire in a safe and effective manner to enhance natural landscapes and support NM agriculture.

What are the liability laws concerning prescribed fire in NM? Strict Liability (deters burning), Simple Negligence, or Gross Negligence (more encouraging to burning)?

Are there provisions in NM law that protect the public right to use prescribed fire as a resource tool? Right to burn statute?

What is the legal process for initiating burn bans?

Does NM public law identify specific guidelines that an individual needs to follow in order to use prescribe fire on one's private land?
