CES Publication Peer Review Process

All new CES publications must go through a peer review before being submitted to the AES/CES publications unit for publishing. In addition, any CES publications that have been revised to include a significant amount of new content must be peer reviewed before publication.

After your manuscript is written, you must submit it to your CES department head along with recommendations for three reviewers--one internal peer (NMSU), one external peer (outside of NMSU), and one intended audience reviewer. The department head may approve the recommended reviewers or suggest alternate reviewers. Once reviewers have been agreed upon and they are able to review your manuscript, provide them with an electronic copy of the manuscript along with the publication review form (http://aces.nmsu.edu/pubs/guidelines/documents/ces-publication-review-form_march-2009.pdf).

Reviewers should return their comments to you, and you should revise the manuscript based on reviewers' comments; if you choose not to revise based on reviewers' comments, you must provide an explanation to your department head when submitting the manuscript for publishing.

Your department head will review the manuscript and the reviewers' comments. If additional changes are required, your department head will return the manuscript to you for changes.

Once the manuscript has been approved, your department head will submit the manuscript, along with the "Request for Approval of Manuscript" form (<http://aces.nmsu.edu/pubs/guidelines/documents/numpubapproval-form.pdf>), to

the AES/CES publications group.
