I currently serve as the Principal Investigator (PI) on USDA-NIFA Section 1444 (1890 Extension) funding of \$2.8 million annually, this funding has grown by 13% since 2017. USDA-NIFA also provides Facilities Funding for which I serve as PI on 4 awards totaling approximately \$ 14 million. I also provide oversight for \$ 1.3 million in SNAP-ED and EFNEP funding. The state of Alabama provides annual funding to support programming activities of approximately \$4.3 million each year. This funding has grown 10.2% in my brief tenure as Extension Administrator in Alabama. Prior to my arrival the Extension program at AAMU had not received an increase in its appropriation in the previous 6 fiscal year funding cycles.

Provided Agency leadership for a 2-phase funding proposal from the Centers for Disease Control and the Cooperative Extension Section of APLU. The grant was designed to provide outreach education to communities experiencing hesitancy related to the COVID-19 vaccination.
